## Timeframe and Process

## Hong Kong Tax Information 2024

Hong Kong's tax system is straight forward and business-friendly, featuring low tax rates and a territorial basis of taxation:

**Corporate Tax (CT):** 0% on foreign-sourced income and 16.5% on local profits.

**Personal Tax:** Progressive rates ranging from 2% to 17%, with numerous allowances and deductions available.

**Other Taxes:** Hong Kong does not impose any VAT, Dividend, Interest or Capital gains taxes.

## Manager's Visa (Emirates ID)

A UAE Free Zone company often includes a manager's visa as part of its business setup package. This visa allows the manager to legally reside and work in the UAE. The manager's visa is typically valid for two years and can be renewed along with the company's license. This visa facilitates the smooth operation and management of the company within the UAE's regulatory framework.

## Yearly Renewal and Annual Requirements

Maintaining a company in Hong Kong involves several annual compliance requirements. Businesses must file annual returns with the Companies Registry and submit annual tax returns along with audited financial statements to the Inland Revenue Department. Timely renewal of business licenses and permits is essential. Our team provides ongoing support to ensure your business meets all these requirements efficiently and remains compliant with local regulations.
